Course Description:

Introduces students to the laws that affect their daily lives. The student will be able to trace the steps in a criminal trial procedure. The student will be able to state and explain an individual's rights if arrested. The student will be able to identify which common defense the defense attorney is using in a case study. The student will list and describe the five sources of U.S. law. The student will be able to depict the structure of the federal and state court systems. The student will be able to identify the elements required for a valid contract, decide if a contract is valid and write an explanation regarding his/her decision. The student will be able to correctly apply terminology related to business and personal law. The student will be able to decide whether or not situations in business demonstrate ethical behavior according to the steps in the "Ethical Decision Making Process" and explain their answer. The student will research and present a career opportunity in the legal profession.
