I TEST POSITIVE FOR COVID-19

A positive student/employee should immediately isolate and stay home for a minimum of 10 calendar days after symptom onset or positive test collection, if asymptomatic. To return to school, the student/employee must be evaluated and receive written clearance to return to school or work.

I DEVELOP SYMPTOMS OF COVID-19

Students or employees with symptoms of COVID-19 should stay home and call their healthcare provider. Students and employees with symptoms at school will be isolated and sent home. If a student/employee has more than one low-risk symptom (e.g. a fever and nausea) or one high risk symptom (e.g. a cough), they will be required to get medical clearance prior to returning to school/work. Students or employees with high risk symptoms should be tested for COVID-19.

I AM IDENTIFIED AS A CLOSE CONTACT OUTSIDE OF SCHOOL

The student/employee should continue coming to school/work, monitor for symptoms and take appropriate actions if they develop any symptoms of COVID-19.

MY FAMILY MEMBER IS A CLOSE CONTACT

I TEST POSITIVE FOR COVID-19

I AM IDENTIFIED AS A CLOSE CONTACT OUTSIDE OF SCHOOL

Outside of school, a close contact is any individual who was within 6 feet of an infected person for at least 15 minutes (accumulated time during the contact's infectious period), starting from 2 days before illness onset (or, for asymptomatic patients, 2 days prior to positive specimen collection) until the time the patient is isolated. Close contacts must stay home and quarantine for **10 calendar days** after last exposure.

MY FAMILY MEMBER IS A CLOSE CONTACT

If a family member in the student or employee's home is quarantined because they were in close contact with an infected person (but the family member is asymptomatic and has not tested positive), the student/employee should continue coming to school/work and monitor symptoms.

MY FAMILY MEMBER HAS SYMPTOMS AND IS AWAITING TEST RESULTS

If a family member is **symptomatic** and awaiting results from a COVID-19 test, the student/employee should stay home until results are received and then follow appropriate protocol according to the results.

MY FAMILY MEMBER IS POSITIVE FOR COVID-19

Stay home and quarantine for **10 calendar days** after last exposure. Return to school/work with a written release. (Please note that if the positive family member does not self-isolate within the home, the quarantine period continues for the close contact through the positive person's isolation period and **10 days beyond** the day the positive person is released from isolation.)
